### Full Members

- \_\_\_\_\_ All retired faculty of Winthrop University who have received the title of emeritus or emerita faculty are eligible to become regular members of the Emeriti College. **Membership fee: \$70 annually.**
- \_\_\_\_\_ All other retired faculty of Winthrop University who have served at least five years at the University and fifteen years in the academic profession may apply for acceptance as regular members. **Membership Fee: \$70 annually.**
- \_\_\_\_\_ Life Member (Life members qualify for the Winthrop President's Circle and associated benefits for the year in which the one-time membership fee is paid. Life membership is inherited by surviving spouses/domestic partners of Life Members). **One-time Membership Fee: \$1000. (Special rate of \$900 for those who join in the calendar year in which they retire)**

### Associate Members

- \_\_\_\_\_ Retired faculty of other colleges or universities who have received the title of emeritus or emerita may apply to be associate members. Once approved, Associate Members shall have the rights and privileges of regular members, including voting, but may not hold office. **Membership Fee: \$70 annually.**

### Affiliate Members

- \_\_\_\_\_ Upon their retirement, Winthrop retirees who had teaching, administrative, and/or research careers that are congruent with the mission of the University and the Emeriti College may apply to be Affiliate Members. Once approved, Affiliate Members may participate in all functions of the College, but may not vote or hold office. **Membership Fee: \$70 annually.**

\*\*\* Membership periods are for calendar years. The membership period for new members who join in the last seven months of the year will extend through the following calendar year.

\*\*\*A second retiree residing at the same address as a fully paid member can receive the same level of membership for 20% of the usual fee.
