VII. Petitions – Erin Hamel

A reminder from Student Academic Services that COESHS petitions are due by November 15. Petitions are not needed if a candidate's Praxis subject assessment score is within one standard deviation of passing. If scores will not be reported until after November 15, candidates should already submit the petition. The changes to the Internship I application last spring for fall 2025 requiring Praxis registration greatly helped decrease Praxis issues moving into Internship II.

Encourage candidates to take the EDCO 591 Praxis prep course for subject assessments before their senior year. We plan to offer the course in spring 2025 and initiating curriculum action to move to a regularly offered course.

If candidates are submitting a Course with Internship form, the candidate should register for the course while the form is being processed.
