Q: Leigh Poole: Can you talk to us about plans for VPN access for our international students?

A: The students don't access the VPN, so it doesn't affect them.

- V. Enrollment Management: Amanda James
  - a. Strong persistence rate: 90% from spring to fall for continuing students
    - i. Second consecutive year of retention increases
  - b. Growth in graduate students: 5% increase
  - c. 2<sup>nd</sup> year of increase of new freshmen: 8% increase for freshmen, and 21% increase for transfers
  - d. Dual enrollment: huge increase
  - e. Development of academic pathways to transfer to Winthrop
    - i. Working with SC technical colleges, and about to partner with CPCC in Charlotte
  - f. FAFSA: praise to the financial aid team
    - i. Not much hope for better FAFSA experience next year
  - g. Events: Open House remains the number one event that students say made them choose Winthrop
  - h. Let her know when you see other colleges doing a good job recruiting, as these are ideas we can try

Q: When we're advising, some students want to take classes back home over the summer. Is there a list that we can reference so students know what classes will count back at Winthrop?

A: You can see all the pathways online. We do have the fully approved list; 88 courses are pre-approved. We want them to fill out an approval to transfer credit form. That's all on the registrar's website.

- VI. Student Affairs: Shelia Higgs Burkhalter
  - a. 98% occupancy in residence halls, 1,991 students
    - i. A lot of upper-class students choose to reside on campus
  - b. Welcome Week events
  - c. Launched a fund for first generation students; will launch first-gen society
  - d. Dean of Students Announcements
    - i. Care team that helps us triage students issues: send us care alerts

- 1. Form online: Maxient
- ii. 182% increase in academic misconduct cases this year because of AI
  - 1. Be very clear with students about what you allow in your courses
  - 2. Many educational sanctions will start at the faculty level: feel free to reach out, but also consult with chairs and deans
- iii. Office of Accessibility
  - 1. Provide a service in a way that honors what faculty are doing in their classes.
  - 2. Work together to find a solution
  - 3. Students are supposed to have conversation with faculty about their accommodations
  - 4. Make sure you use Closed Captioning: Office of Online Learning can help
- iv. Title IX: new guidelines arrived on August 1, 2024
  - 1. Got an injunction so were told not to implement, so we are still using 2020 regulations
  - 2. As soon as we know what we're supposed to do, we will update everything
  - 3. Suggest students reach out to Kevin Sheppard if they need it
  - 4. New policy for pregnant and related students: let students know that the title IX coordinator is here to make sure their rights are taken care of
  - 5. General ADA policy guidelines for campus forthcoming
- v. Career Center
  - 1. In Bancroft 3<sup>rd</sup> floor
  - 2. Partnered with College of Business and Technology: use Handshake for internships, both local and global
- vi. Center for Student Wellness
  - 1. Staying in Joynes Hall this year

    - i. Please don't use incomplete grades for interim grades

    - i. Outlook autofills and sends email to the wrong people, and then information gets send to students which violates FERPA
