II. Report from the Graduate School Dean: SC Graduate Education Week is February 13-17, 2017. Please refer to the handout for details. It is important to emphasize that staff are encouraged to participate in the Regalia Day event so as to make the event more visible and highlight the number of graduate degrees on campus outside of faculty. All events will be well advertised and there is a dedicated website for information on all of the public events. A special logo has been designed. Along with a lot of social media plugs, there will be table tents in Thomson and DiGS, as well as a competition during Regalia Day for students to take selfies with F/S in their gowns and post to social media. Faculty and staff are invited to join President Mahony in Thomson for lunch on Monday as well.

Tracy Griggs mentioned that a larger conversation regarding the barriers that students face when considering graduate education needs to be had. Return on investment is a definite concern for our current undergrads.

Kelly Richardson said that she was going to start the discussion with her students about the main differences between undergraduates and graduates as sometimes those lines are blurred when just looking at the curriculum.

Antje Mays asked for the number of our undergraduates that go on to pursue a PhD. Our numbers match the national average for a Liberal Arts, non-research I institution. While we cannot compete with the larger schools, there are changes in the market that are working to push changes in programs to match need.

Dean DeRochi went on to discuss his recent attendance at both the EAB and CGS conferences and provided data and information gleaned from both.

- 43% of students surveyed said that debt limits their ability to go to graduate school
- 40% of all school loan debt is from graduate school costs but that is only 15% of the total students
- 81% of job seekers are searching for employment in a category other than their own they will hold over 20 different jobs in their lifetime
- These students are looking for constant pivots, enhancements, and employment protection in future jobs.

Certificates, badges, and even stackable certificates within existing programs are the rising ideas to drive enrollment and meet need. How do we professionalize our graduate courses? How do employers view badges?

Therefore, we are removing Practicum III (3) and Stats II (3) as noted on the attached and decreasing the degree program by 6 hrs. Approved.
 - ii. MS-BIOL modify Addition of an accelerated one-year BS to MS Option. This option was made possible by Winthrop's recently changed policy allowing students to take up to 9 hours of coursework during their undergraduate programs which can also count toward a graduate degree program. Approved.
