Graduate enrollment is flat at 792/793. This ends three straight fall declines. The fact that enrollment is flat from last year shows that the floor has been raised and our normal graduate student portfolio should be around 850. CSDV online is a great success. EdD passed the first CHE hurdle.

The Graduate Studies office is working on two items that this council can assist with: continuing to push graduate education forward and fostering community with the students. Graduate Student Appreciation Week is April 7-13th – please consider adding the 3MGS to spring course syllabi as great professional development event.

GSO plans to launch a Graduate Student Newsletter in the spring to help build community and make sure students feel connected. Gabby is lead – will be reaching out ahead of time for program specific events, alumni notes, etc. Welcome any suggestions to improve in these areas. DH (Dustin Hoffman) noted that English or Writing Center GAs could be helpful to use.
